CLUBBED INTO SUBMISSION.

20,000 of the Philadelphia Crowd Beaten by the Police.

Mob Trampled by Men and Horses and Scattered About.

Discipline and Strategy Win Against Wild Mob.

Philadelphia, March 14.-The police fought and whipped 20,000 strikers and their sympathizers in the heart of the city this afternoon. Broad street, from the Philadelphia National League Park to the City Hall, was a battleground for two hours.

The great thoroughfare was choked with men and women, who struggled to break down the police barricades and surround the City Hall. Hundreds of them were pounded to the street stones, trampled by men and horses, kicked and cuffed, and whirled headlong to side streets. It is impossible to say how many were hurt. The police troubled to make few arrests, but after the mob was split and broken and its parts were driven helter-skelter into the side streets, you saw scores of men-now and then a womanwhose head had been cut open by savage blows of a club; whose faces were bloody, or who were nursing an arm paralyzed by the smashing impast of the policeman's mace.

TRUCK LOAD OF MILLINERY. Broad street was a curious spectacie after the battle had roared itself away and none were left but the files of policemen on guard. For squares the asphalt was littered with hatsmen's hate and women's head coverings that had been crushed and swept away in the driving rushes of the policemen. A truck load of damaged millinery might have been gathered up. There were shoes that had been torn off by their owners and thrown at the police, and many of them were women's.

The unions had obtained, as they said, permission from President Horace Fogel, of the baseball club, to use the park. Their final word last night was that the meeting would be held despite Clay or anybody else. It was a straight-out defiance to the city authorities an invitation to trouble They were busy all night recruiting forces. They depended on 2,000 brawny mechanics and boilermakers who had struck at the Baldwin Locomotive Works to lead the march to the City Hall. Clay ordered John Taylor, Superintendent of Police, to take as many men as necessary and prevent the strikers from assembling in the baseball park, or anywhere else.

Suddenly the crowd realized that Pratt and Murphy, with members of the committee of ten, had arrived in an automobile and were demanding admittance to the park. There was a surging toward the gate, where they were arguing. It was obvious that the number of police had increased. Telephone calls had brought detachments from car barns and police stations, where they had been in re-

OVER 1,000 POLICEMEN.

Then the van understood that Taylor was blocking the way. For a distance of two miles, from the baseball grounds to Spring Garden street, he had posted at short intervals more than 1,000 policemen, while troops of police cavalry trotted up and down the sides of Broad street, held in reserve. Taylor commanded in person.

A short distance from the ball park a squad of "brownies," the negro policemen, blocked the street. They were ordered to tear into the crowd, and they did it wickedly. At the same moment a troop of mounted men rode into the crowd from the side, cutting off a thousand or more of the marchers from the main body. It was the beginning of the strategy that had been planned to divide the mob into sections and then hammer each section into the nearest side street. The plan was carried out systematically and ruthlessly.

At York street Taylor's men ripped into the first of the sections, clubbing concealing the true facts in connection savagely. The mounted men drove the people against the sides of buildings, pushing them hard, until they yelled for mercy. The police horses knocked men and women sprawling. The air rang

with curses.

WOMEN HAD MOST SPUNK. Street by street, the details of police directed by Taylor hammered the crowds off the public highways. The women displayed more sounk than the men. They were seen to claw at the faces of the bluecoats and hurl shoes straight at Taylor's men. When they refused to be driven, they were knocked down. It was not at all uncommon to see a woman pick herself up clutching at her head. At Norris street, where a wall of policemen had been stationed by Taylor, the advancing crowd spied two trolley cars that had been stopped near Broad street. The motormen were looking curiously from their platforms. Voices started up in the crowd: "Here they are, kill



St. Catharines despatch: The R. W. Grand Lodge, representing 30,040 members in good standing, deplores the prevalence of gambling throughout the country, an evil that saps the foundation of character and tends to demoral ize the community, and most strongly commends the patriotism of those men who, both in public and private life, have courageously grappled with this vice in an endeavor to mitigate the evil and expresses the sincere hope that they will receive hearty support, particularly from the Parliamentary representatives of the Province of Ontario, and further expresses astonishment at the course of all those who advance the specious and fallacious arguments that are offered in defence and to secure the continuance of this pernicious practice under the authority of the laws of Canada, from interested motives of various kinds; and, while we commend the course of that portion of the press which by its opposition to bookmaking and gambling has correctly voiced the sentiments of the community on the question, we most strongly condemn the practice of publishing reports from Canadian and foreign race tracks, thereby aiding the operations of the bookmakers and professional gamblers, and call for the enact ment of legislation to prohibit the publication and disemination of such information, and of bookmaking and gambling in all its forms, and that copies of this resolution be sent to Sir Wilfrid Laurier. FOUGHT DOG.

Powerful Collie Made Savage Attack on Perth Farmers.


