An Open Letter to the Council of the Village of Jarvis.

GENTLEMEN:—At the time that
our village was incorporated one of
the principal arguments used in
favor of the incorporation was that
the village would then have control
of all matters arising within its
limits and that they could pass such
by-laws as they desired for them-
selves. It was expected that any
by-laws that might be passed would
be enforced, and in fact, if I under-
stand it aright, a special officer was
appointed to see that the by-laws
of the village were enforced. In-
stead of that, your honorable body
has become a laughing stock. The
majority of us must keep our dogs
properly muzzled but some make a
joke of it and others simply neglect
their duty altogether. Some of us
cannot ride our bicycles on the
sidewalks while others can do as
they please in this regard and open-
ly defy the authorities to enforce
the by-laws. Gentlemen, is it fear
or favor that causes this state of
affairs?

These matters referred to however
are not nearly so serious as one
that has become a public scandal in
the village. It must be known to
some of you, if not to you all, that
there exists within the limits of
this village what is practically a
house of ill-fame or disorderly
premises. It is a shame and dis-
grace to your body as well as to
the village that this plague spot is
allowed to exist. Now then gentle-
men you can not plead ignorance
any longer and it is up to you to
act.

W. P. Thompson's Prize.

W. Palmer Thompson has been recom-
mended by the Senate of Toronto Uni-
versity to His Majesty's Commissioners
for the 1861 Exhibition Scholarship. This
prize amounts to £150 or \$750 annually
and is for two years at any university in
England or abroad. Capacity for original
research must be the qualification of the
winner and it is open for competition to
the scientific departments of the Uni-
versity.

Mr. Thompson's thesis was "The origin
of ray tracheids in the coniferae." He
has been working in the botanical depart-
ment of the University and will be gradu-
ated in June. He is only 21 years old
and was born in Walpole Township. He
came to Toronto from Jarvis and entered
Victoria for an arts course. The young
prizeman has decided to spend his first
year at Harvard University under Profes-
sor Jeffrey. The scholarship was found-
ed in commemoration of the Crystal Pal-
ace Exhibition of 1851.—Toronto Even-

that this Council expend the sum of six
hundred dollars on account of sidewalks
this spring, and that the Standard Paving
Company be given the contract, they to
work under the same contract as they
had with the Police Village in 1908, and
that the Council be instructed to notify
the Company that they are now ready to
go to the work.—Carried.

Mr. Heartwell, the assessor, returned
his Assessment Roll.
On motion the Council adjourned to
meet again on Tuesday evening, May 17,
