Fixed Assessment.

Simcoe taxpayers are to be asked to grant the British-Knit Co. a fixed assessment of \$6,700 on their plant. The company find its present plant too small and negotiations were under way for the purchase of the Slav Overall building. British-Knit has a payroll of \$50,000 and that figure is being increased annually as the demand for the product was constant. Over 125 hands were given year-round employment with no slack period other than two weeks' holidays.

OBITUARY

The late William Smith.
William Smith, senior member of the firm of Wm. Smith & Son, furniture dealers, a former mayor and one of Leamington's most prominent citizens, died Monday morning at the home of his son, R. E. Smith, Russell street. He was in his 81st year and had been in poor health for a year and a half with heart trouble.

Mr. Smith was born in Moreyshire, Scotland, and came to Canada when 3 years of age. He spent his boyhood days and until his marriage at Jarvis Ont. He had been engaged in the furniture business for 55 years, 43 of which were in Leamington.
Mr. Smith held the confidence and esteem of his fellow citizens. He took an active interest in the municipal affairs of the town in former years, having sat on the Council Board for several terms and was afterwards elected mayor about 25 years ago. He was also a member of the Public Library Board for several years, was a member of the Odd-fellows order for 49 years, and until a few years ago was a prominent bowler. In politics he was a Conservative and in religion a Presbyterian.

The only survivors are a son, R. E. Smith, and one daughter, Mrs. (Dr.) Chambers of London, Ontario.
The funeral service was held at his late home Wednesday afternoon at 2.30 with interment at Lakeview cemetery.
The late William Smith will be remembered by many in the village and community as the eldest son of the late John Smith and Christina Innes. His father being proprietor of the Commercial hotel here and also conducted a hotel at one time near the Nanticoke creek, about a mile south of Jarvis. The brothers and sisters who have predeceased him were, Mrs. J. A. Burwash, Mrs. (Doe) Mascear, Mrs. Beaupre, Mrs. Doan, and Charles Smith. He has 2 brothers living, Robert in Toronto and John in Portland, Oregon. His wife, who before her marriage was Fanny Locke, predeceased him several years ago.

Hon. William Andrew Charlton
At his home in the city of Toronto, Sunday last, the Hon. William A. Charlton, dean of the surviving speakers of the Ontario Legislature and for many years the local member for the riding of South Norfolk, passed to the great beyond.
Mr. Charlton, who was in his ninety-third year, was born in the State of New York, but came to Canada when eight years of age. After receiving his early education in Waterloo county, he moved to Norfolk and settled in Lynedoch, with his brother, the late John Charlton, where they opened up and conducted a general merchandising business which proved very successful. He was also very successful in the lumber business.
During the past twenty-five years he has lived in Toronto, but always spent his summers in his beautiful home in the village of Lynedoch where he was so well and favorably known.
At the time of his death Mr. Charlton was President of the Chartered Trust and Executor Company and of the National Sanatorium Association. He was a Liberal in politics until the formation of the Union Government when he strongly supported the Unionist cause and since that time has taken no active part in politics, but had devoted his time to humanitarian interests. His life was full of good deeds and effective public service. In the many years that he was actively engaged in the political field he never made an enemy, and no man could ever say that he ever took a mean advantage of a political opponent and in all his career his one thought was for the betterment of mankind. His remains were taken to his old home at Lynedoch where service was held and interment took place in Lynedoch cemetery.

Prominent in Canadian military circles for over 65 years, and one of the best known men in this section of Western Ontario, Lieut.-Col. David McCrea, father of the late Colonel John McCrea, author of the immortal poem, "The Flower Fields" died on Friday last. Although in failing health for some time, his death came unexpectedly.

SIMCOE CHAPEL IS SAVED FROM RUIN

BUILT AT WOLFORD, EAST DEVON, IN 1800, BY GENERAL SIMCOE

The following interesting article by Fred Williams, published in the Mail and Empire this morning, refers to General John Graves Simcoe, after whom the town of Simcoe was named. It reads as follows:
"The chapel at Wolford, East Devon, in which General Simcoe, the founder of Toronto, lies buried, was saved from decay by an English newspaper. Five years ago Wolford was visited by Rev. Alexander Sharp, M.A., of St. Barnabas Church, Plymouth, who is a graduate of Trinity University, Toronto, and therefore, interested in the preservation of any link between Canada and the mother country. He was astounded to find that the Simcoe chapel had been allowed to go to practical ruin. On his return to Plymouth he wrote an article describing the situation, which was published in the Western Morning News. That journal sent representatives to Wolford and they immediately realized that one day the chapel, if properly preserved, would become a point of pilgrimage for Canadians and especially for folk from Ontario. And the Western Morning News (whose proprietor was Sir Leicester Harmsworth) purchased the chapel and its burying ground, including the graves of the general, his wife and children. The general's home and estate were sold and the household treasures are scattered throughout the kingdom, except that part of the library and two oil paintings of Simcoe were purchased by Sir Leicester.
"The chapel was built by General Simcoe in 1800. A stone in the end wall reads:
"Sacred to the Memory of Lt.-Gen. John Graves Simcoe, who died October 26th, 1806, aged 54. His mortal remains were buried at the foot of this stone six years after he had erected this chapel to the glory of God and the manifestation of the purpose in which he lived and died. As for me and my house, we will serve the Lord." — Joshua xxiv, 15.
"He left a widow and nine children to lament his loss.
"Another tablet records that Elizabeth F. Simcoe, the beloved wife of Lt.-Gen. John Graves Simcoe, died Jan. 17, 1850 after 44 years of widowhood passed at Wolford Lodge and grave at the foot of this stone by her remaining six children in the sure and certain hope of a joyful resurrection. A third stone is sacred to the memory of the infant children of John Graves Simcoe and of Elizabeth F. Simcoe, his wife—Katherine, 16th Jan. 1793, died and was buried at York Town in that province, 17th April, 1794 and John Cornwall, who was born at Wolford Lodge, July 7th 1798, died March 29th, 1799, and is buried near this stone. Other tablets are to the memory of Francis Gwilliam Simcoe, the eldest son who, as lieutenant of the 27th Foot, fell in the breach at the siege of Badoez, April 6th, 1812, in the 21st year of his age; of Eliza Simcoe, the eldest daughter, who died at Bath, Aug. 12th, 1853; of Charlotte Simcoe, second daughter, who died at Leamington, Warwickshire, July 28th, 1842; of Henrietta Maria, third daughter, who died at Wolford Lodge, March 16th, 1845; of Caroline, fourth daughter, who died at Bath and was buried Sept. 21st, 1858; of Sophia Jemima, fifth daughter, who died at Bath and was buried Feb. 18th, 1864; and of Katharine, the seventh daughter (named after the first) who died at Bath, February 22nd, 1861.
"In Exeter cathedral there stands in the south aisle, Flaxman's memorial, considered one of the finest works of that great sculptor, on which is inscribed:
Sacred to the Memory of John Graves Simcoe, Lieutenant-General in the Army and Colonel of the 22nd Regiment of Foot, who died on the 26th day of October, 1806, aged 54.
"In whose life and character the virtues of the Hero, the Patriot and the Christian were so eminently conspicuous that it may justly be said he served his King and his country with a zeal exceeded only by his piety towards his God.
"At the left of the monument is a figure of an English soldier with reversed musket; in the centre a bust of General Simcoe in white marble; and on the right a North American Indian with tomahawk. The memorial is surmounted by crest and flags.
"Concluding, let me ask if you know the difference between ermine and ermines, which figure in the Simcoe coat of arms? Ermine is white with black spots, while ermines is black with white spots, so that the addition of the "s" gives the reverse definition."
