WEAK SUBSTITUTES

It had been several weeks since I had last seen my friend Thomas. Christmas services, increasing sickness and many other duties had left little time for casual or neighbourly visits. When at last, I did call at his home I found him busy writing letters to friends and relatives, telling of the Christmas celebrations. Of course, we had much to talk about, and for a little while we exchanged. Presently, the conversation became centered around the Christmas festival, and more particularly about the "special" programmes carried over the Television and Radio networks. Generally speaking, Thomas was not too impressed by the overall quality or quality of these special Christmas presentations. Many of the excellent traditional stories and musicals associated with the season were missing, and in their place "advertisements" were presented. "For instance," said Thomas, "did you see the musical programme which was a play adapted from the New Testament? 'Suite' ? Well, it was a pretty poor substitute for Tchaikovsky's masterpiece."

Strange, how so many great and wonderful things have been lost through too much adaptation. Of course, there is nothing wrong in changing our moods and music to the tempo of our times, but let us not substitute "anemic adaptations" for the real masterpieces.

In this present generation we have become rather expert at adaptation,

particularly in the realms of music, writing, and religion. Many of the great classics of musical genius, have been adapted so that they form the underlying theme for modern "hot numbers." The timeless and beautiful stories to be found in the pages of Old Testament and New Testament literature have become the happy hunting ground for those producing the "sexy" films demanded by many for their entertainment.

Likewise, many people today have only experienced Christianity in its adapted, modified and inbred form, never really knowing that dynamic, courageous, vibrant faith that long ago, "turned the world upside down." It is little wonder, therefore, that many have been unmoved and untouched by this "anemic religiosity" finding it unequal to the sudden demands they make upon it.

Much of our so-called Christianity today demands only a "passing acknowledgement" of God with no need for complete commitment to Him. It is a "faith for tough times" only of little consequence - in days of "smooth sailing." Requires little by way of love, thankfulness, and service as expressed through daily worship and prayer.

The faith to which Christ calls men is an active, daily surrender to His will, and a seeking after His purpose. It is a practice of His presence every day, experience, an interpretation of His teachings in this present generation.

FEDERAL GRANT APPROVED FOR PLANS DEVELOPING FOR NEW VOCATIONAL SCHOOL HOSPITAL FUND CAMPAIGN

John A. Charlton, M.P. announced on Tuesday, on behalf of Hon. Michael Starr, Minister of Labour in the Federal Government, that a grant, amounting to \$1,301,626.00 had been approved for the new Vocational School that will be erected at Cayuga, Ontario.

The petition for the grant was made by the Ontario Government including plans for the new school. With the approval of the plans the Federal Government's share of the cost, which is 75% was also approved.

The estimated cost of the new building is \$1,889,992.00. The balance of the cost will be borne by the Ontario Government.

It is reported that the total cost to local taxpayers for the new school structure, designed to accommodate 800 students will be less than \$34,000.00.

The West Haldimand Hospital Campaign Committee held a meeting in the Council Chambers at Hagersville on Thursday, December 28th to discuss policy matters concerning the Building Fund Campaign for the 55 bed hospital which is expected to be started in mid 1962 and which is to cost \$225,000. Representatives from the Haldimand Hospital Area, Cayuga, Jarvis, Fisherville and Selkirk and the townships of Seneca, Oneida, Walpole and Rainham attended and undertook to accept various positions of leadership in the campaign.

It was announced that Dr. R. G. Hyde, Hagersville, has accepted the position of General Chairman of the

Campaign Committee and Hon. Chairmen will include: Judge Helen Kinney, Hon. James N. Allan, Provincial Treasurer and Harrison Arrell, Q.C. of Caledonia. The Fund raising campaign will take approximately three months to complete and will be aimed at raising \$175,000 by public subscription which will be applied towards the overall cost of the hospital. This is the most ambitious Fund raising project ever attempted in West Haldimand.

The Campaign will ultimately call for a Volunteer Organization of over three hundred people drawn from throughout West Haldimand County. The Committee will in the next couple of months be continuously adding to its members as the main drive takes place in March an effective Volunteer Force will canvass the entire Hospital Service area.

The Headquarters of the Campaign are situated in Hagersville at 415 Main Street, R.O. 8-3111. Divisional Centres will be set up at strategic points across West Haldimand for the training of Volunteers during the course of the Campaign.

HOW TO BOWL FIVE PINS:

FOOTWORK COUNTS ON THE APPROACH

To get from your starting point to the spot where you release the ball just in front of the foul line, requires a certain number of steps. Exactly how many steps you need depends on your personal style of delivery. It can vary from one step to five steps.

A three-step approach and a four-step approach are by far the most common, however. These two approaches are used by 80 per cent of bowlers. The one-step, two-step and five-step approaches are unorthodox. Still, some good bowlers do use them. In addition, some of these approaches may be best for handicapped people, many of whom are able to bowl well.

Find the number of steps that seems most natural to you, then use this type of approach. Only in this way can you develop the proper rhythm of movement so important to good bowling.

WHERE SHOULD YOU STAND? After deciding the number of steps you are going to take, here's how to find how far back from the foul line you should start off:

You want to complete your delivery with your forward foot about six inches in front of the foul line.

So, stand with your back toward the pins, and place your heels six inches from the foul line. Then with an imaginary ball in your hand, go through the entire delivery, taking the number of steps you plan to use, and sliding at the end. Do everything just as if you were bowling a real ball toward the pins instead of toward the crotch.

Notice where your forward foot stops. This will be your starting point when you actually bowl.

You can fix this spot in your mind by noticing where it is located relative to the standard marker dots that are spotted in three lines from 12 to 16 feet back of the foul line. A more exact way of fixing this spot, however, is to check where it is in relation to the balls on the return rack, for example, you may start out opposite the third (or fourth, or fifth) ball on the rack.

Be sure not to try this experience with a real ball. A number of display case windows have been shattered by bowlers who have done this. Almost certainly the ball will slip out of your hand, perhaps injuring someone.

But, even though you are not using a ball, include all the motions you just learned in your regular delivery. THE THREE-STEP APPROACH Of the two "orthodox" approaches, the three-step is the one most popular with 5-pin bowlers, and the one to try first if you are just starting to bowl.

In all cases, you finish your approach with your left foot sliding forward, provided you are a right-handed bowler. Left-handed bowlers just reverse the sequence of steps, and end with their right foot forward.

1st Step: Left foot forward, and give the ball its pushaway.

2nd Step: Right foot forward, swinging the ball smoothly backward to shoulder height.

3rd Step: Left foot forward for slide. As the arm swings forward, the right knee drops, and the ball is released a few inches from the floor. Follow through with your arm.

THE FOUR-STEP APPROACH The four-step approach is the second most popular one with bowlers. Many four-steps, however, take only a half step on their first step, giving themselves more time for the pushaway; then they go through the rest of the sequence as if doing a three-step approach. This gives them a fuller pushaway and a longer backswing than an ordinary three-step approach.

For a full four-step approach, however, the sequence is this (reverse, if you are left-handed):

1st Step: Right foot forward; and give the ball its pushaway.

2nd Step: Left foot forward; and half the backswing is completed.

3rd Step: Right foot forward; back swing is completed.

4th Step: Left foot forward for slide. As the arm swings forward, the right knee drops and ball is released a few inches from the floor. Follow through with your arm.

Remember, choose the type of approach that feels best to you. It is not the number of steps you take which is important. The important thing is coordinating the movement of your arm with the movement of your feet for a smooth, accurate delivery.
